

EMS-001-001 Environmental Policy

Alliance Wine, the UK's leading wine distributor, and independently owned suppliers of wine to the on trade and independent off trade channels, as well to select international customers, is committed to controlling and preventing contamination, as well as reducing their environmental impacts that could derive from their operational activities.

Alliance Wine's Environmental Management System (EMS) is a structured approach to managing our environmental responsibilities. Aligned with ISO 14001, it enables us to reduce our environmental impact, comply with regulations, and continuously improve our practices. Below is a summary of key activities within our EMS that reflect our core commitments.

In our philosophy of continual improvement, we hope to expand the scope of the System to all our activities.

The senior management of Alliance Wine declares:

- The commitment to maintain an EMS, directing its efforts to the search for a greater degree of environmental compatibility in carrying out our hydraulic works, through continual improvement.
- The commitment to avoid environmental contamination and restore nature through continual improvement of
 their environmental action by establishing environmental objectives and goals identified from the environmental
 aspects of their activities.
- Complying with current legal requirements and any requirements applicable to environmental protection.
- Wherever it is aware of the existence of a risk not covered by the legislation, it will establish its own environmental standards and practices to adequately protect public health and the environment.
- Risk management will be a common practice in the organization focused on the treatment of risks associated
 with either adverse (threats) or beneficial environmental impacts and with significant environmental aspects
 that may result in the risk associated with any of adverse environmental impacts environmental impacts
 (opportunities).
- Following the principles of continual improvement so as to ensure the effectiveness of our environmental performance.
- Reducing the consumption of natural resources in daily operations, including water, and energy.
 Usage of renewable energy sources.
- Reducing the waste generation in our facilities and wine events through the execution of anti-waste policies that include the correct waste segregation.
- Control, monitor and reducing of our carbon footprint aligned with ISO14064. Annual certification audits.
 Insetting activities for residual emissions.
- Application of eco-design standards to reduce the environmental impact of the packaging items that we select for our own wine labels.
- Communicating our environmental objectives and goals to our stakeholders in order to allow them to carry out their activities with an environmentally responsible approach and according to our environmental policy.
- Work with our suppliers and subcontractors to control and improve their environmental performance.



- Provides adequate training to staff and encourages them to develop good environmental practices at work.
- Reporting transparently on the company's environmental performance in both internal and external communications.
- Reviewing this policy annually and measuring targets and performance as part of that review.
